1. Introduction

A. Purpose

GlobalFarmers.com is a social media network and global knowledge sharing platform for farming and agriculture professionals who can be clients of or associated with Rabobank, or can be third parties not related to Rabobank as well, to promote the sharing of knowledge to assist professionals to be more knowledgeable, productive and successful. It is also a network to share Rabobank's expertise and international network in food and agribusiness banking, views on cooperative banking and sustainability and global food security.

Rabobank makes the GlobalFarmers.com platform available to you to help you, your colleagues, and other farmers meet, exchange ideas, learn, find opportunities, work and make decisions in a united network of farming and agricultural professionals. GlobalFarmers.com is available to all users free of charge.

B. Conditions of using the GlobalFarmers.com platform

Any personal information that is collected by us in connection with your registration for and use of the GlobalFarmers.com platform will be collected and handled in accordance with our Privacy Policy. Your privacy is important to us and we encourage you to read our Privacy Policy applicable to your country to discover how Rabobank collects, uses, shares, and stores your personal information. You agree that by registering on GlobalFarmers.com or by using the GlobalFarmers.com website(s) and/or applications and/or any content or information provided as part of GlobalFarmers.com (“GlobalFarmers.com platform”), you are entering into a legally binding agreement with Coöperatieve Rabobank U.A. (“we,” “us,” “our,” and “Rabobank”) based on these Conditions as a registered user on GlobalFarmers.com (“Member”).

By clicking “Enter” or similar, or by using any related service, you acknowledge that you have read and understood and are bound by these Conditions. References to Rabobank in these Conditions include subsidiaries, affiliates, related bodies corporate, officers, directors, employees, agents and representatives of Rabobank.

The Conditions may be amended from time to time. The most up-to-date version of these Conditions will always be available on the GlobalFarmers.com platform and we will use our reasonable endeavours to notify you of any amendments that may materially affect your use of the Services as outlined in Section 2G below. If you do not accept any of the amendments to the Conditions, you may terminate your account in accordance with Section 6 below. Your continued use of the GlobalFarmers.com platform shall constitute your acceptance of any amended Conditions.

2. Your Rights & Obligations

A. GlobalFarmers.com rules

When using or accessing the GlobalFarmers.com platform, you must comply with the Conditions of Use published and available on the GlobalFarmers.com platform.

B. Information that you post or share

As between you and Rabobank, you own all of the content and information you post on the GlobalFarmers.com platform. You may request that content and information that you post be deleted from the GlobalFarmers.com platform at any time, and we will use our reasonable efforts to remove it. We may be unable to delete content that has been shared with other GlobalFarmers.com

users (for instance on the GlobalFarmers.com Forum), or that has been copied or stored by other GlobalFarmers.com users. Once you terminated your membership of GlobalFarmers.com, all information you posted on the GlobalFarmers.com Forum will remain in the Forum threads, but you will no longer be identifiable by name as the poster of the Forum posts concerned. Deletion of content will not affect any licence granted to Rabobank in relation to that content.

You grant Rabobank a non-exclusive, worldwide, royalty-free right to use and exploit in any way content (for instance by including the content you publish on GlobalFarmers.com in a separate newsletter that we may release outside GlobalFarmers.com) and information that you provide directly or indirectly to us via the GlobalFarmers.com platform as permitted by applicable law. We will not be required to obtain any further consent from you, or provide any notice or compensation to you in relation to that use.

Other GlobalFarmers.com users will have access to your content and information and rights to share it in accordance with these Conditions, the Privacy Policy, your settings and your connection to those other GlobalFarmers.com users. You can control access by other GlobalFarmers.com users and their sharing rights as well as the publishing scope of your content by altering your settings.

You remain responsible for any content or information that you post on the GlobalFarmers.com platform and must ensure that all content complies with the GlobalFarmers.com rules (see Section 9 of the Conditions).

You are responsible for obtaining the authorisation of any individual whose personal information you post to the GlobalFarmers.com Platform to the collection and use of the individuals' personal information by Rabobank in accordance with these Conditions and the Privacy Policy. Any content or information you submit to us is at your own risk of loss and we do not commit to maintain any copy or back up of that information. We furthermore reserve the right to adjust or remove the content or information you submit to us, for instance if your contribution consists of promotion of companies and their products, deemed undesired by GlobalFarmers (see Section 3B).

C. Eligibility

To be eligible to access and use the GlobalFarmers.com platform, you must meet the following criteria and represent and warrant that you:

- (1) are 18 years or older;
- (2) are not currently restricted or prohibited by us or any third party from using the GlobalFarmers.com platform;
- (3) are not a competitor of Rabobank and are not using the GlobalFarmers.com platform other than for the purposes of your own farming or agricultural business;
- (4) will only maintain one GlobalFarmers.com account at any given time;
- (5) will use your real full name and only provide accurate information to us in relation to the GlobalFarmers.com platform;
- (6) have full power and authority to enter into these Conditions;

(7) will not, in your use of the GlobalFarmers.com platform, violate any rights of Rabobank or any third party, including intellectual property rights;

(8) agree to provide at your own cost all equipment, software, mobile access, and internet access necessary to use the GlobalFarmers.com platform;

(9) not to promote/advertise the activities of your own or third parties' company and/or products/services on GlobalFarmers.com.

D. Usership

The profile you create on the GlobalFarmers.com platform will become part of GlobalFarmers.com and, except for the content and information that you license to us, the intellectual property rights in it are owned by Rabobank.

However, between you and others, your account belongs to you.

You must keep your account secure in accordance with the GlobalFarmers.com rules (Section 9). If you believe that your GlobalFarmers.com account has been compromised, you should immediately change your password. If you believe that an unauthorised person continues to have access to your account you should notify Rabobank immediately by email to support@globalfarmers.com.

You are responsible for anything that happens through your GlobalFarmers.com account until you close down your account or prove that your account was compromised due to no fault of your own. You may close your GlobalFarmers.com account at any time. To close your GlobalFarmers.com account, please email Rabobank on support@globalfarmers.com for GlobalFarmers.com. Please see Section 6 ("Termination").

E. Indemnification

If anyone brings a claim against Rabobank related to or connected with your use of GlobalFarmers.com, you agree to indemnify us and hold us harmless from and against all damages, losses, expenses and costs (including reasonable legal fees and costs) caused by content and/or information you post or share, and any failure on your part to comply with these Conditions and the GlobalFarmers.com rules, and any applicable laws.

F. Notification

If you believe that you are entitled or obligated to act contrary to these Conditions under any mandatory law or regulations, you must cease to use the GlobalFarmers.com platform.

G. Service Messages, Notices and Alerts

For the purposes of service messages and notices about GlobalFarmers.com, we may place a banner notice across GlobalFarmers.com pages to alert you about significant changes such as amendments to these Conditions.

Rabobank may also issue notices and alerts to your nominated email address. You agree that Rabobank may communicate with you through your GlobalFarmers.com account or through other means including email or telephone, in accordance with these Conditions and the Privacy Policy.

Please review your GlobalFarmers.com account settings to manage the kinds of messages, notices and alerts you receive from us.

H. Information on the GlobalFarmers.com platform

We attempt to provide accurate and complete information obtained from reliable sources. However, we make no guarantees or representations, express or implied, about any information or content found on or through the GlobalFarmers.com platform, including any information related to users, third parties, and/or Rabobank. Please see further Section 4 (Disclaimer) below.

You will not obtain rights (including copyrights, trademarks, patents and any other intellectual property rights) to any content and information provided on the GlobalFarmers.com platform (including all texts, graphics and logos) other than information that you have posted. You are entitled to view this content and information on the GlobalFarmers.com platform, but these rights do not give rise to a licence of those rights to you.

I. GlobalFarmers.com Applications

GlobalFarmers.com may offer applications on the GlobalFarmers.com platform (i.e. computer programs designed to perform a group of coordinated functions, tasks, or activities for the benefit of the user) ("Applications"). Examples of Applications include smartphone applications. 3. Our Rights & Obligations

A. Services Availability

We plan to update, improve and expand the GlobalFarmers.com platform over time. We grant you access to the GlobalFarmers.com platform as it may exist and be available on any given day ("as is") and we have no other obligations, except as expressly stated in these Conditions. Depending on Rabobank's business requirements over time, Rabobank may modify, replace, suspend or discontinue access to the GlobalFarmers.com platform, partially or entirely, or charge and/or modify a fee prospectively for all or part of the GlobalFarmers.com platform. We will use reasonable endeavours to provide you with prior notice of any such changes either through the GlobalFarmers.com platform or by direct communication to you. If you do not wish to accept any changes proposed by Rabobank, you must cease using the GlobalFarmers.com and terminate your GlobalFarmers.com account as outlined elsewhere in these Conditions.

B. Removal and alteration of information

Rabobank has no obligation to store, maintain or provide you a copy of any content that you or other registered GlobalFarmers.com users provide when using the GlobalFarmers.com platform.

Rabobank reserves the right, but is under no obligation, to alter or to take down any content or information that is posted in breach of these Conditions or the GlobalFarmers.com rules (Section 9), or that Rabobank otherwise deems (in its sole discretion) to be inappropriate content for the GlobalFarmers.com platform. - respond to customer service enquiries; or
- protect the rights, property, or personal safety of Rabobank, registered GlobalFarmers.com users or the members of public.

We may make other disclosures of personal information as outlined in the Privacy Policy.

E. Connections and Interactions with other Users

You are solely responsible for your interactions with other GlobalFarmers.com users. We may limit the number of connections you may have to other GlobalFarmers.com users and may, in certain circumstances, prohibit you from contacting other GlobalFarmers.com users through the GlobalFarmers.com platform or otherwise limit your use of GlobalFarmers.com. We reserve the right, but have no obligation, to monitor or mediate disputes between you and other GlobalFarmers.com users and to restrict, suspend, or close your account if we determine, in our sole discretion, that doing so is necessary to enforce these Conditions.

Rabobank shall not be liable for (a) any damages in excess of US\$100 or the amount you paid Rabobank, if any, in the past six (6) months for the use of the GlobalFarmers.com platform giving rise to the claim, whichever amount is greater, or (b) any indirect, special, incidental, punitive, consequential or exemplary damages or loss of use, profit, revenue or data to you or any third person (even if Rabobank is advised of the possibility thereof) arising from your use of

This limitation of liability shall apply regardless of whether your claim is based on guarantee, contract, tort (including negligence), statute or otherwise, and whether or not Rabobank knew or should have known about the possibility of any such damages, or the limited remedies provided in this section fail in their essential purpose.

This limitation of liability shall not apply to any damage that GlobalFarmers.com may cause you intentionally or knowingly in violation of these Conditions or as otherwise mandated by applicable law that cannot be disclaimed in these Conditions.

6. Termination

A. Mutual rights of termination

These Conditions (as may be amended from time to time) will apply to your use of the GlobalFarmers.com platform until terminated by either you or us.

You may terminate your GlobalFarmers.com account and your agreement with Rabobank on these Conditions at any time. You may provide notice of termination to us by message through GlobalFarmers.com platform, by email to support@globalfarmers.com. This notice will be effective upon Rabobank processing your notice (which it will do in a reasonable time).

Rabobank may suspend or terminate your account, if you are in breach of any of these Conditions or the GlobalFarmers.com rules (Section 9), or if you cease to be a Rabobank client, a Rabobank employee or otherwise linked to Rabobank and may suspend or terminate its provision of the GlobalFarmers.com platform account if it, in Rabobank's sole discretion, is no longer in its business interest to provide the platform.

Suspension or termination shall be effective immediately or as may be specified in any notice given to you.

Termination of your GlobalFarmers.com account includes disabling your access to GlobalFarmers.com and may also bar you from any future use of GlobalFarmers.com.

B. Effect of Termination

Upon termination of your account, you lose access to GlobalFarmers.com. The terms of these Conditions shall survive any termination, except Section 3 ("Our Rights & Obligations").

7. Dispute Resolution and Indemnification

A. Jurisdiction of Legal Disputes

Any claim, cause of action or dispute (“claim”) arising out of or in connection with these Conditions shall be governed by the laws of The Netherlands regardless of your country of origin or where you access GlobalFarmers.com, and notwithstanding any conflicts of law principles. You and Rabobank agree that all claims arising out of or in connection with these Conditions must be resolved exclusively by a court located in The Netherlands, except as otherwise agreed by the parties. You and Rabobank agree to submit to the personal jurisdiction of the courts located within The Netherlands for the purpose of litigating all such claims. Notwithstanding the above, you agree that Rabobank shall still be allowed to apply for injunctive remedies (or an equivalent type of urgent legal relief) in any appropriate jurisdiction of competent jurisdiction.

B. Indemnification

If anyone brings a claim against us related to your use, content or information on GlobalFarmers.com, you will indemnify and hold us harmless from and against all damages, losses, and expenses of any kind (including reasonable legal fees and costs) arising out of or in connection with such claim. Although we provide rules for conduct, we do not control or direct users' actions on GlobalFarmers.com and are not responsible for the content or information users upload, transmit or share on or through GlobalFarmers.com. We are not responsible for any offensive, inappropriate, obscene, unlawful or otherwise unacceptable content or information you may encounter on GlobalFarmers.com. We are not in any way responsible or liable for the conduct of any user of GlobalFarmers.com.

8. General Terms

A. Severability

If any provision of these Conditions is found by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, such provision will be severed and the validity, legality and enforceability of the remaining provisions of these Conditions will not be affected or impaired in any way and these Conditions will be construed so as most nearly to give effect to the intent as it was when these Conditions were originally entered into.

B. Language

Where Rabobank has provided you with a translation of the English language version of these Conditions, the Privacy Policy, or any other documentation, you agree that the translation is provided for your convenience only and that the English language versions of these Conditions, the Privacy Policy, and any other documentation, will govern your relationship with Rabobank in relation to GlobalFarmers.com.

C. Notices and Service of Process

We may notify you through notifications, messages or other postings on GlobalFarmers.com platform or any other GlobalFarmers.com site or application or contact you by electronic communication to your electronic address you notify to us from time to time in accordance with the Privacy Policy. You may contact us by email to support@globalfarmers.com or via mail to Global Farmers, Croeselaan 18, 3521 CB Utrecht, The Netherlands. Any notices that you provide without compliance with this section shall have no legal effect.

D. Entire Agreement

You agree that these Conditions constitute the entire, complete and exclusive agreement between you and Rabobank regarding GlobalFarmers.com and supersedes all prior agreements and understandings between you and Rabobank with respect to the subject matter of these Conditions. You also may be subject to additional terms and conditions that may apply when you use certain other GlobalFarmers.com services or third-party content.

E. No informal waivers, agreements or representations

Any failure to exercise and delay in exercising any right, power or remedy by us under these Conditions will not operate as a waiver and no single or partial exercise of any right, power or remedy by us will preclude any other or further exercise of that or any other right, power or remedy.

Our failure to act with respect to a breach of these Conditions by you or others does not waive our right to act with respect to that breach or subsequent similar or other breaches. Except as expressly and specifically contemplated by these Conditions, no representations, statements, consents, waivers or other acts or omissions by any Rabobank affiliate shall be deemed legally binding on any Rabobank affiliate, unless documented in a physical writing hand signed by a duly authorised officer of GlobalFarmers.com.

G. Assignment

You may not assign any rights or obligations under these Conditions and any purported assignment and delegation shall be ineffective. We may freely assign all of our rights and obligations under these Conditions, fully or partially without notice to you and may substitute, by way of unilateral novation, effective upon notice to you, Rabobank for any third party that assumes our rights and obligations under these Conditions in connection with a merger, acquisition, or sale of assets, or by operation of law.

H. Other Rights and Obligations

If you are located outside The Netherlands you may have rights or obligations under mandatory local law that are additional or alternative to those enumerated in these Conditions.

9. GlobalFarmers.com rules

As a condition of your access to and use of GlobalFarmers.com platform, you agree to the terms of these Conditions and to strictly observe and comply with the following rules:

A. When you use the GlobalFarmers.com platform, you must:

1. comply with all applicable laws, including but not limited to privacy and data protection laws, intellectual property laws, tax laws and regulatory requirements;
2. provide truthful, accurate and up-to-date information at all times;
3. take reasonable measures to protect your personal information such as your email address, phone number, street address, or other information that is confidential in nature;

 - e. not charging anyone for access to any portion of the GlobalFarmers.com platform.
8. obtain the authorisation of any individual whose personal information you post to the GlobalFarmers.com platform for the collection and use of the individuals' personal information by Rabobank in accordance with the Conditions and the Privacy Policy.
9. be considerate to other users when expressing oneself and sharing information. This includes but is not limited to words and tone of voice used.

B. When you use the GlobalFarmers.com platform, you must not:

1. act dishonestly or unprofessionally by engaging in unprofessional behaviour;
